45 th	SEPT 22	Early voting clerk may begin mailing early voting ballots to applicants on or before September 22
30 th	OCT 7	<ul style="list-style-type: none"> First day of period during which Notice of Election must be published
28 th	OCT 9	<ul style="list-style-type: none"> Last day to register to vote for the Tuesday, November 6 election Last day for a voter to make a change of address that will be effective for the election Last day for a person to apply for a full ballot by mail using a FPCA if the person is not a registered voter, but meets the requirements under Title 2 of the Election Code
21 st	OCT 16	Last day to post Notice of Election on bulletin board used for posting notices of meetings of governing body
15 th	OCT 22	First day to vote early in person
8 th	OCT 29	Last day of period during which Notice of Election must be published
7 th	OCT 30	Last day to receive FPCA or application for a ballot to be voted by mail
4 th	NOV 2	Last day to vote early by personal appearance
Election Day	NOV 6	<ul style="list-style-type: none"> Polls open 7:00 AM to 7:00 PM 7:00 PM - Deadline for receiving early voting ballots by mail
3 rd day after	NOV 9	First day to conduct official local canvass of returns by governing authority
8 th day after	NOV 14	FBISD to conduct official local canvass of returns by governing authority
22 Months following election	SEPT 7 2009	Contents of ballot box #3 may be destroyed if no contest or criminal investigation has arisen, and if no open records request is pending, unless required to be permanently maintained in the election register.
